#### PHI DELT SECURES 23 PHIKEIAS ... THE LARGEST CLASS IN A LONG WHILE


he phone call I had eagerly anticipated came at 5:45 Friday afternoon, August 27. The Phi Delts gave out 29 bids and secured 23 new phikeias! Their biggest competitor secured eight pledges. The three rush chairmen — John McTyiere '01, Matthew Cooke '02, and Durant Bell '02 (my son) — and the entire House did an outstanding job with rush this year.

Perhaps the Phi Delts had been a little too dependent on Charlotte and Atlanta over the

last several years. (Three years ago, for example, these two cities represented approximately 60 percent of all the Phi Delt brothers.) This year, the 23 phikeias are from 12 different cities and eight states, which is a better balance and geographical diversification. This class is probably the strongest and largest Phi Delt class in the last six or seven years. As a frame of reference, the average pledge class size this year was 10. There are now 21 active fraternities at UNC. Only 310 young men went through fall rush, and 210 joined a fraternity.

As a parent of a Phi Delt sophomore, an alumnus, and active member of the Beta Foundation, I have tremendous pride in these young men. They have an exciting future and truly represent some

Our Capital Campaign was a huge success, thanks to your generosity. Over 460 Phi Delts pledged more than \$1.2 million. ### ALCOHOL FREE JULY 1, 2000

#### Phi Delt Alumni:

Over the course of the last two years, we have been faced with the fact that all Phi Delt chapter houses nationally will become alcohol-free facilities beginning July 1 of the year 2000. This means that alcoholic beverages will not be permitted in the chapter house or on the property, regardless of age.

The goals of the national fraternity in moving to alcohol-free housing is to refocus on the values of the fraternity, move away from an alcohol dominated fraternity environment, meet the needs of today's college student, and stabilize the rising liability insurance costs.

The North Carolina Beta Foundation has formed a special committee to research the alcohol-free policy and to determine

how other chapters around the country are dealing with this same issue. We have talked at length with Ron Binder, the director of Greek affairs, as well as representatives from the Phi Delt National headquarters. Currently, we believe that our option is to either become alcohol free by July 1, 2000, or to become a "local fraternity" that is not regulated by Phi Delt National.

There are numerous disadvantages to being a "local fraternity," such as higher insurance costs, not being recognized by the University, and not being able to have a mixer with some sororities because we would not be alcohol free. However, the active brothers and Beta Foundation are concerned about some issues that might arise from the alcohol-free policy. Over the past several years, fall rush has been a cutthroat competition with three fraternities including Phi Delt competing for the same group of 20-25 guys. While we have been fortunate and obtained the best pledge class on campus this year, our rushees tend to prefer an active social program with parties at the fraternity house. Next year, we would like to obtain 15-20 more pledges and keep Phi Gam and Beta to this year's number of 16 and 7 pledges, respectively. However, with Beta not going dry, we are concerned that this will be a major recruiting disadvantage for us in the future.

Our chapter continues to be the best on campus. No other fraternity over the years at Chapel Hill has been so dominate as the Phi Delts The alumni and Beta Foundation have worked extremely hard to provide the undergraduate brothers with the best facility on campus and to ensure that Phi Delt remains the best fraternity on campus for many years to come.

The undergraduate brothers and the Beta Foundation will continue to work hard on all matters concerning the alcohol-free policy. Collectively, we want to make an informed decision that will enable Phi Delt to remain the best fraternity at UNC. At the present time, the Beta Foundation does not have an answer and we would appreciate any input from alumni regarding this issue.
