STATUS UPDATE

A Letter from the Beta Foundation President

UNC Phi Delta Theta Brothers:

On behalf of the North Carolina Beta Foundation, I hope 2020 is off to a great start for everyone. The last several months have been challenging ones for our Chapter on campus. We have been dealing with the University's Student Code of Conduct Office and working our way through a violation and the repercussions of the school's new alcohol policy, which went into effect at the beginning of the school year. In summary, the Chapter was charged, investigated and found guilty in an Honor Court trial, which led to a recommended punishment of a one-year suspension of the Chapter as a student organization.

"Phi Delt is one of the top chapters on campus and the guys are not only leaders within the Greek system but the University as a whole." While we are not denying the violation occurred, we strongly disagreed with the severity of the sanctions that were handed down as they were not based on past precedence for violations of this type. We spent the better part of four months going through an appeal process within the university presenting our case and more accurately portraying the whole story, which we did not feel happened within the Honor Court's

system. In summary, the suspension was reduced from one year to six months. The Chapter is still allowed to participate in philanthropic events and recruit new members during rush next fall, neither of which were permitted in the original sanctions.

We do know now, however, that the University's viewpoint on fraternities in general continues to evolve in an unfavorable way. We must be prepared to take steps to adapt and make sure we stay around and relevant for years to come. In our Chapter's most recent visit report from the Phi Delt Nationals Leadership Consultant in the fall, the Office of Fraternity and Sorority Life at Carolina told the representative, "Phi Delt is one of the top chapters on campus and the guys are not only leaders within the Greek system but the University as a whole." Phi Delt at UNC has remained one of the top Chapters on campus for many decades and we are committed to remaining that way well into the future. Despite this bump in the road, we have a great set of guys currently in the house and plan to build on that moving forward.

Please remember that your continued financial support is greatly appreciated and does not go unnoticed. This support is reflected by the makeup of active brothers and the condition of our Chapter house, both the best on campus. An Undergraduate Update from Phi Delta Theta President David Stukey

Over this academic year, a lot has taken place at the Phi Delta Theta house. As Scott Gunn indicates in the opening letter, we are dealing with some violations that have resulted in a sixmonth suspension. But on a brighter note, the Chapter has continued the Phi Delta Theta legacy of giving back to Chapel Hill.

Last spring, we hosted the ALS cookout raising over \$3,000 towards finding a cure for ALS. In November, along with Pi Phi, we held the 12th annual Eve Carson Memorial 5k. With over 300 runners participating, including those close to Eve, the event raised \$40,000 towards the Eve Carson Memorial Fund, the Literacy Fund and CEO 4 Teens.

Brothers have also taken the philanthropic initiative beyond the walls of Phi Delt. Junior Warner Lamar runs an organization called Focus on Franklin. Focus on Franklin's goal is to use the process of diversion to keep those at high risk of homelessness from going homeless.



The group has kept over 30 families from going homeless since 2017. We thank Warner for his continued efforts to fight homelessness.

While it may have been a down year for the varsity basketball team, not to mention the entire March Madness tournament and the remainder of spring sports being cancelled due to Coronavirus, that didn't stop some of our own from shining on the court with the junior varsity (JV) team. Junior Thomas Bledsoe and

freshman Duwe Farris both started for the JV team, playing positions 4 and 5 respectively, while junior Graham Dale served as assistant coach.

This upcoming April, we will once again be holding the annual Luke Garrison Memorial Golf Tournament. Please be on the look-out for updates regarding this golf tournament in the future, as we look forward to connecting with alumni over a round of golf celebrating Luke Garrison's life

While it has been an up-and-down year here at the Phi Delta Theta House, we look forward to the next academic year as we continue to better ourselves as people and as a fraternity. Once things calm down with the pandemic and social distancing, we look forward to Alumni visiting for games and stopping in to the House for a visit. As always, Go Heels.



KITCHEN UPDATE

Board Agrees on Improvements



Since the preliminary estimates for the kitchen and dining room upgrades were too high, the Board has agreed to modernize the kitchen as it now stands. We will order a new dishwasher and probably a microwave or food warmer which, will enhance the food coming out of the kitchen. We also want to consider some new prep tables and possibly a new stove. That way, in the future, if we want to expand the kitchen and dining room as previously planned, we can easily do it. We suspect

the Board will only approve it when enough money is in the savings to handle the full cost.

We think this is prudent at this time with the University expanding their control of the Fraternity activities in the future which, may reduce the number of young men wanting to join a social Fraternity. We will wait to see what effect the University regulations do to the Fraternity family at UNC and revisit this expansion in the future.
