LETTER FROM THE BOARD

Active Chapter Apologizes; Alumni Forge Path to Strong and Sustainable Chapter Return

We hope everyone is having a nice spring, enjoying the warmer weather, and continuing to stay safe in this COVID world that we are all still living in. After several months since our last communication, we wanted to take a moment to provide everyone with an update on the status of the Phi Delt house at Chapel Hill and the progress that we have made in addressing our suspension and planning a path moving forward.

Since our last update, there are a handful of initiatives that the Active Chapter, the NC Beta Foundation Board, and some other alumni have been working on that should help the chapter return to good standing with the University and Phi Delt Nationals in the future. After reflecting back on the mistakes that were made over the last several years and the pattern of bad behavior, it was apparent that a new approach at the house was needed to ensure longevity in the future. The first step in this process involved a shift from a defensive mode trying to justify rules violations to accepting responsibility for past mistakes and apologizing for those actions and poor judgement. The second step involved a commitment from the Chapter to agree to an extensive cultural change from the ways of the past and agreeing to implement new policies and procedures of everyone moving forward. The NC Beta Foundation, along with some other concerned alumni, have played an active role in facilitating this rehabilitation of the Chapter but of course, none of it will be possible without the involvement and participation of the current brothers at the house and your support as an Alumni.

With the help of some Alumni who have relationships with University Board of Trustee members, we began formulating a plan to repair our relationship with the University because we knew that was the right thing to do and imperative for the Chapters return to good standing on campus. In early February, three Beta Foundation members and two other

Alumni reached out to Chancellor Guskiewicz who graciously accepted our request to have a meeting to discuss the initiatives that we were working on with the Chapter. The purpose of the meeting was to apologize for the organizations past mistakes, share with him some of the reforms that we were planning to implement along with the Chapter members, and request an opportunity for the Chapter members to personally meet with him in the future to apologize for their actions and collaborate on future reforms. Some of the things that will be implemented in the future include professional leadership training and development programs required for all chapter members, additional community services requirements for everyone and more for those who planned and attended the party in August, an adult advisor living in the house when it reopens to mitigate risk, a renewed focus on diversity, equity, and inclusion within the Chapter, and the commitment to helping the rest of the Greek system on Campus to implement similar things which are needed in the eyes of the University. Even though we did not ask for anything from the Chancellor other than his administration's feedback and help with these reforms, he was very appreciative of the organization's efforts so far and was excited about the things we are working on along with the brothers.

Several weeks after this meeting, Officers from the Chapter and members of each individual class also had an opportunity to meet with the Chancellor to apologize for their actions that led to the suspension, ask for forgiveness, reaffirm their commitment to the reforms that are being implemented, and ask for the opportunity to work with the administration on all of these projects. Chancellor Guskiewicz also shared some ideas that he had about opportunities for collaboration with the Chapter on some community service areas that would help him out. Overall, we feel like these two initial

meetings could not have gone any better and that we are now on the right path to returning to good standing. The first community service event involving campus cleanup took place on March 24th and many more are being planned for the future. The Beta Foundation is also in discussion with two leadership development programs for the chapter to participate in that we hope to have in place this semester.

Ongoing discussions with representatives of Phi Delta Theta Nationals have also been taking place simultaneously with those with the University. The National organization has their own playbook for suspended chapters and we are working hard to align their policies with those of the University, Active Chapter, and NC Beta Foundation. We have made progress on their willingness to help us with these reforms and teaching opportunity and hope to have their support on this path.

Currently, we are in discussions with them about a chapter rehabilitation program that was successfully orchestrated at the University of Arkansas in 2009. This plan could potentially circumvent the Chapter's Charter being suspended like the recognition from the

University was revoked in exchange for having them be actively involved with implementing best practices. Our hope is that a similar plan would allow the organization to rehabilitate without having to start over from scratch once the suspension term is up.

The decision was made in January to close the house for this spring semester as a preemptive measure and to allow time to formulate our strategy moving forward. We are still working on a plan and a timeline for reopening the house to some extent in the future, but it will depend on how our continued dialogues with both Nationals and the University go, we will plan to share new information with you as it becomes available. We have revamped the strategy and makeup of the NC Beta Foundation (more about this can be found below) to bring in some new faces and ideas to do some heavy lifting with this project. Even though we are dealing with an interruption of income from dues and house rents, the finances of the organization currently remain in good standing from years of sound fiscal responsibility, savings, and of course, your financial support. We encourage all of you to continue to stay involved during this transition period to ensure our strong return.

Even though the Chapter is still suspended and there is still lots of work to be done, the NC Beta Board is committed to doing our best to turn this negative into a positive and make this a teaching moment for all of these young men. In addition, the Greek System in Chapel Hill is under increased scrutiny and in need of reform and we hope to be the leaders in this regard and set examples that others will soon follow. The Phi Delt Chapter at Carolina has a long-standing history of being leaders on campus and we have an opportunity to continue that tradition and return to good standing. We encourage you as alumni to continue to stay involved financially, ask questions, and support our efforts to a future return stronger than ever and we look forward to providing you with further updates on our progress.
